## **HOW TO APPLY:**

**To be considered for admission to MSU PhD Programme, fill in the following forms & send the supporting documents to Maldives National University before the application deadline (4 January 2018)**

- Application of Admission form
- Photocopy of National Identity Card (Front & Back) and Passport (all pages)
- Bachelor's & Master's degrees Certificate & Academic Results Transcripts (2 copies)
- Two (2) Reference Forms from two (2) different Referees
- Proposed title/topic and objective of research (one page)

**Maldivian students enrolled in the PhD programme will be able to pursue their studies in Maldives. MSU Professors will deliver any necessary lectures in MNU premises.**

## **DURATION OF CANDIDATURE:**

**The minimum duration of candidature for PhD programmes is 3 years and the maximum duration is 5 years (full time) and 7 years (part-time).**

## **TUITION FEES:**

Students shall pay the tuition fees to Management and Science University (MSU) in full during the enrollment period prior to each Year, in order to complete the enrollment procedures.

The tuition fee is RM 13000 per year (total 39,000 for 3 years).  
Students also have to pay a registration fee of RM 6900 during the first year and a Thesis fee of RM 5000 at the end of the third year.

The aim of the PhD program is to provide research training in a manner that fosters the development of independent research skills in candidates. These skills include the capacity to formulate a significant problem, to develop mastery of appropriate conceptual and methodological skills, and to relate the research topic to a broader framework of knowledge in the relevant disciplinary area.
